The Committee of Adjustment will hold a public meeting to gather feedback regarding the Minor Variance application to consider the proposal. The details are as follows:

Purpose and Effect of the Application

The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the minimum interior side yard setback requirement for a property zoned Urban Residential First Density – Exception (UR1-3) Zone. The applicant is requesting a minimum interior side yard setback of 1.8 metres (5.9 feet) on either side of a dwelling, whereas the Middlesex Centre Comprehensive Zoning By-law requires a minimum interior side yard setback of 3.0 metres (10 feet) on either side. The effect of the proposal is to facilitate the construction of a new single detached dwelling.

Proposal Summary

Requirements	Relief Requested
As per section 8.3.3 (e) (i), the minimum interior side yard setback for a dwelling is 3.0 metres (10 feet).	

Description and Location of the Subject Lands

The subject property is located on the east side of Komoka Road, just north of the intersection of Komoka Road and Simcoe Ave in Komoka. The land is legally described as Part of lots 3 and 4, and Lot 5, Block R, Plan 109, in the Municipality of Middlesex Centre, County of Middlesex.
