Public Meeting

Council will hold a public meeting to consider the proposed consent applications. The details are as follows:

Purpose and Effect of the Consent Application:

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B8/2023 is to sever one lot from an existing single detached dwelling lot. The application seeks to sever a lot with a frontage of approximately 22.97 metres (75 feet) on Ilderton Road, and an area of approximately 815.39 square metres (0.2 acres). The retained residential lot would have a frontage of approximately 23.24 metres (76 feet) on Ilderton Road, and an area of approximately 842.26 square metres (0.21 acres). The effect would be to create one new residential lot for the purpose of establishing a new dwelling unit, while maintaining the existing dwelling on a separate lot.

The lands are designated Residential in Middlesex Centre's Official Plan and are zoned a Urban Residential First Density (UR1) Zone in Middlesex Centre's Comprehensive Zoning By-law.

Description and Location of Subject Land:

The subject property is located on the south side of Ilderton Road, east of the intersection at Hyde Park Road and Ilderton Road in Ilderton. The land is legally described as Part of Lot 24, Concession 10, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 13433 Ilderton Road.

About the Public Meeting

What can I expect at the Public Meeting?

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. If you have questions about the application, we encourage you to contact the Planner directly in advance of the meeting as they may be able to answer your questions.

How to Participate in the Public Meeting

- 2) SUBMIT WRITTEN COMMENTS to the Municipal Clerk at <u>clerk@middlesexcentre.ca</u>. Comments will form part of the public record and will be circulated to Council and staff. Please be aware that if you are submitting correspondence to the Municipality of Middlesex Centre regarding this application, your name, contact information, and communications may become party of the public record that will be available to the general public, pursuant to the *Planning Act* and the *Municipal Freedom of Information and Protection and Privacy Act*.
- 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- ATTEND THE MEETING IN PERSON at the Middlesex Centre Municipal Office. Any members of the public who wish to speak to an application will be given the opportunity to do so.

Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
