

## **Purpose and Effect of the Consent Application:**

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B12/2023 is to sever a surplus farm residence on a lot with a frontage of approximately 85 metres (278.87 feet) on Ilderton Road and an area of approximately 1.99 acres (0.81 hectares). The retained farmland would maintain a broken frontage of approximately 200 metres (656.17 feet) on Ilderton Road, and an area of approximately 48 acres (19.42 hectares). The applicant is proposing to maintain a single detached dwelling and associated services as well as an existing garage/ shed on the severed lands. The remnant parcel would be maintained as farmland in crop production.

The lands are designated Agricultural in Middlesex Centre's Official Plan and are zoned an Agricultural (A1) Zone in Middlesex Centre's Comprehensive Zoning By-law.



## **Description and Location of Subject Land:**

The subject property is located on the north side of Ilderton Road (County Road 16), west of Denfield Road (County Road 20). The land is legally described as Part of Lot 30, Concession 11 South, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 12626 Ilderton Road (County Road 16).

#### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
