#### **Purpose and Effect of the Application**


The Municipality is seeking input on a development application within 60 metres of your property. The purpose and effect of the Application for Minor Variance is to seek relief from the Middlesex Centre Comprehensive Zoning By-law 2005-005 as it relates to the maximum lot coverage requirements for an accessory building in the in the Urban Residential First Density – Exception (UR1-4) Zone. The applicant is proposing to construct an accessory building which would bring the total site coverage for accessory structure to 109 m2 or 5.5 percent lot coverage, whereas the Zoning By-law permits a maximum size of the lesser of 50 m2 or 3 percent lot coverage. The effect is to permit the construct of an additional accessory building in the format of a detached garage.

# **Description and Location of the Subject Lands**

The subject property is located on the south side of Railway Ave in Komoka, south of the intersection at Railway Ave and Queen Street. The land is legally described as Lot 9 to 12, Part of lot 2 to Part Lot 4, Block 8, Plan 109, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 150 Railway Ave.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the

person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 45(12) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
