
Purpose and Effect of the Consent Application:

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B-21-2023 is to sever a surplus farm residence on a lot with a frontage of approximately 45.7 metres (150 feet) on Lamont Drive and an area of approximately 1 acre (0.4hectares). The retained farmland would maintain a broken frontage of approximately 508 metres (1667 feet) on Lamont Drive, and an area of approximately 83.72 acres (33.9 hectares). The applicant is proposing to maintain a single detached dwelling, associated detached car garage and associated services on the severed lands. The remnant parcel would be maintained as farmland in crop production.

The lands are designated Agricultural in Middlesex Centre's Official Plan and are zoned an Agricultural (A1) Zone in Middlesex Centre's Comprehensive Zoning By-law.

Description and Location of Subject Land:

The subject property is located on the south side of Lamont Drive, with frontage on Egremont Drive. It is northeast of the intersection at Lamont Drive and Egremont Drive (County Road 22). The land is legally described as Part of Lot 11, Lobo Concession 5 North, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 10701 Lamont Drive.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. If you have questions about the application, we encourage you to contact the Planner directly in advance of the meeting as they may be able to answer your questions.

Other Information:

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
