
### **Purpose and Effect of the Consent Application:**

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B-10-2024 is to sever a farm parcel with a frontage of approximately 342 m (1,122 ft) on Clarke Road and an area of approximately 42 ha (103 ac). The retained farmland would maintain a frontage of approximately 606.7 m (1,990.5 ft) on Ilderton Road, and an area of approximately 42 ha (103 ac). The applicant proposes to maintain the retained parcel for farmland with a single detached dwelling, barns and sheds, and associated services. The severed parcel would be maintained as farmland.

The land is designated Agricultural in Middlesex Centre's Official Plan and zoned 'Agricultural (A1)' in Middlesex Centre's Comprehensive Zoning By-law.

### **Description and Location of Subject Land:**

The subject property is irregularly shaped and located on the south side of Ilderton Road and west side of Clarke Road. The land is legally described as Concession 10 Pt Lots 5 and 6, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 15601 Ilderton Road.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. #### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
