
Purpose and Effect of the Consent Application:

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B-11-2024 is to sever a surplus farm residence on a lot with a frontage of approximately 48 m (157.48 ft) on Greystead Drive and an area of approximately 1.43 ha (1.07 ac). The retained farmland would maintain a frontage of approximately 435 m (1, 429. 5 ft) on Greystead Drive, and an area of approximately 25.5 ha (63 ac). The applicant is proposing to maintain a single detached dwelling, outbuildings and associated services on the severed land. The remnant parcel would be maintained as farmland in crop production with natural heritage features.

The land is designated Agricultural in Middlesex Centre's Official Plan and zoned 'Agricultural (A1)' in Middlesex Centre's Comprehensive Zoning By-law.

Description and Location of Subject Land:

The subject property is irregularly shaped and located southwest corner of Greystead Drive and Vanneck Road. The land is legally described as Concession 11 Part Lot 23, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 12147 Greystead Drive.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. Please be aware that if you are submitting correspondence to the Municipality of Middlesex Centre regarding this application, your name, contact information, and communications may

- become party of the public record that will be available to the general public, pursuant to the *Planning Act* and the *Municipal Freedom of Information and Protection and Privacy Act*.
- 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- 4) **ATTEND THE MEETING IN PERSON** at the Ilderton Community Centre (13168 Ilderton Rd). Any members of the public who wish to speak to an application will be given the opportunity to do so.

Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 51(48.3) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
