
#### **Purpose and Effect of the Consent Application:**

The Municipality is seeking input on a development application that is located within 120 metres of your property. The purpose and effect of Consent Application B-15-2024 is to sever the subject lands into two lots to allow for the sale of property to two separate corporations. The application is seeking to sever the lot back to its original lot lines as the property was previously merged on title. The application would sever a lot with a frontage of approximately 29.63 metres (97 feet) on Egremont Drive, and an area of approximately 6355 square metres (0.64 hectares). The retained lot would maintain a frontage of approximately 32.93 metres (108 feet) on Egremont Drive, and an area of approximately 6889 square metres (0.69 hectares). The effect would be to create one lot for the purpose of a tire sales shop and to create the other lot for the operations of an automobile rust proofing business.

The property is designated 'Agricultural Area' in the County of Middlesex Official Plan. It is designated 'Hamlet' in the Middlesex Centre Official Plan. Additionally, the lands are zoned 'Highway Commercial (C2) Zone' by Middlesex Centre's Comprehensive Zoning By-law.

## **Description and Location of Subject Land:**

The subject lands are located on the north side of Egremont Drive, northeast of the intersection of Egremont Drive and Nairn Road. The subject lands are legally known as Part of Lot 13, Concession 4 in the Municipality of Middlesex Centre (geographic Township of Lobo), in Middlesex County. The subject lands are municipally known as 6378 Egremont Drive (County Road 22).

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. #### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the application is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal.

If a person or public body does not make an oral submission(s) at a public meeting, or make written submissions to the Municipality of Middlesex Centre before the application is passed, the person or public body may not be added as a party to the hearing of an appeal before the Tribunal unless, in the opinion of the Board, there are reasonable grounds to do so.

Notwithstanding the above, subsection 53(19) of the Planning Act prescribes the eligible 'persons' that may appeal the decision to the Ontario Land Tribunal.
