Purpose and Effect of the Application

The Municipality is seeking input on a development application within 120 metres of your property.

The purpose of the zoning by-law amendment application is to rezone the retained farm parcel from the 'Agricultural (A1)' zone to the 'Agricultural – No Residences (A3)' zone to prohibit any new residential uses, and to rezone the non-farm parcel from the 'Agricultural (A1)' zone to the 'Surplus Residence exception (SR-x)' zone to recognize the non-farm dwelling and a reduced lot frontage of 28.96 m (95 ft).

This application is related to an Application for Consent (File: B-20-2023) which was conditionally granted by the Ontario Land Tribunal subject to, amongst other matters, an approved zoning by-law amendment.


In accordance with Section 34(10.4) of the Planning Act, R.S.O. 1990, c. P.13, as amended, the Municipality of Middlesex Centre has deemed this application to be complete for the purposes of Section 34(10.1) and (10.2) of the Planning Act.

Description and Location of the Subject Lands

The subject property is located on the south side of Ilderton Road (CR16) and Richmond (Kings Highway 4), on the southeast side of the intersection of the aforementioned roads. The land is legally described as Part of Lot 16, London Concession 10, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 14387 Ilderton Road.

The public meeting is an opportunity for members of the public to learn more about the proposed development via a brief presentation, ask questions, and/or make statements either in favour of, or in opposition to the proposal. If you have questions about the application, we encourage you to contact the Planner directly in advance of the meeting as they may be able to answer your questions.

How to Participate in the Public Meeting

- 2) **SUBMIT WRITTEN COMMENTS** to the Municipal Clerk at clerk@middlesexcentre.ca. Comments will form part of the public record and will be circulated to Council and staff. Please be aware that if you are submitting correspondence to the Municipality of Middlesex Centre regarding this application, your name, contact information, and communications may become party of the public record that will be available to the general public, pursuant to the *Planning Act* and the *Municipal Freedom of Information and Protection and Privacy Act*.
- 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- 4) **ATTEND THE MEETING IN PERSON** at the Ilderton Community Centre (13168 Ilderton Rd). Any members of the public who wish to speak to an application will be given the opportunity to do so.

How to Stay Informed

Other Information

If a person or public body would otherwise have an ability to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal but the person or public body does not make oral submissions at a public meeting or make written submissions to the Council before the by-law is passed, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Council before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

Notwithstanding the above, section 34(19) of the Planning Act identifies the eligible persons that may appeal a decision to the Ontario Land Tribunal.
