## Purpose and Effect of the Application

The Municipality is seeking input on a development application within 120 metres of your property.

The purpose of the Zoning By-law Amendment application is to rezone the retained farm parcel from the 'Agricultural (A1)' zone to the 'Agricultural – No Residences (A3)' zone to prohibit any new residential uses, and to rezone the non-farm parcel from the 'Agricultural (A1)' zone to a new site-specific 'Surplus Residence exception (SR-x)' zone to recognize the non-farm dwelling and a Minimum Lot Frontage of 25.14 m and Minimum Rear Yard Setback of 1.2 m.

This application is related to an application for Consent (File: B-19-2023) which was conditionally granted to, amongst other matters, an approved zoning by-law amendment.



# **Description and Location of the Subject Lands**

The subject property is located on the north side of Twelve Mile Road, west of the intersection at Twelve Mile and Denfield Road. The land is legally described as Part of Lot 30, Concession 12 South, in the Municipality of Middlesex Centre, County of Middlesex, and is municipally known as 12674 Twelve Mile Road.

- 3) **SPEAK TO COUNCIL** remotely by pre-registering with the Planning Department by emailing <u>planning@middlesexcentre.ca</u>. Upon receipt of your email, you will receive a reply with instructions for obtaining your unique Zoom link in order to participate in the Public Meeting.
- 4) **ATTEND THE MEETING IN PERSON** at the Ilderton Community Centre. Any members of the public who wish to speak to an application will be given the opportunity to do so.

#### Other Information

If a person or public body does not make oral submissions at a public meeting or make a written submission(s) to the Municipality of Middlesex Centre before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Municipality of Middlesex Centre to the Ontario Land Tribunal. In addition, a person or public body may not be added as a party to the hearing of an appeal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

If a person or public body would otherwise have an ability to appeal the decision of the Municipality of Middlesex Centre to the Ontario Land Tribunal but the person or public body does not make

oral submissions at a public meeting or make written submissions to Municipality of Middlesex Centre before the by-law is passed, the person or public body is not entitled to appeal the decision.

Notwithstanding the above, section 34(19) of the Planning Act identifies the eligible 'persons' that may appeal a decision to the Ontario Land Tribunal.
